"Legacy" LWV Position on Health Care (1993, 2016*)

The League of Women Voters of the United States believes that a basic level of quality health care at an affordable cost should be available to all U.S. residents. Other U.S. health care policy goals should include the equitable distribution of services, efficient and economical delivery of care, advancement of medical research and technology, and a reasonable total national expenditure level for health care.

*Behavioral Health added via concurrence

Updated LWV Position on Health Care* (2022)

Main point

The League supports the single-payer concept as a viable and desirable approach to implement League positions on equitable access, affordability and financial feasibility.

Also:

- Expanded delivery options (telehealth, home health)
- Safe staffing
- (a few other points)

Healthy CA for All Commission (1)

- Established 2019 to develop "a plan that includes options for advancing progress toward a health care delivery system in California that provides coverage and access through a unified financing system, including, but not limited to, a single-payer financing system, for all Californians."
- Vision: Health care that is accessible, affordable, equitable, high-quality and universal
- "Unified financing" describes a statewide system to arrange, pay for, and assure health care in which:
 - All Californians will be entitled to receive a standard package of health care services
 - Entitlement will not vary by age, employment status, disability status, income, immigration status, or other characteristics
 - Distinctions among Medicare, Medi-Cal, employer-sponsored insurance, and individual market coverage will be eliminated

Healthy CA for All Commission (2)

Report (2022):

- Notes shortcomings of status quo
- Analyzes and describes potential advantages of UF
 - lives saved: 4,000 per year
 - \$ saved compared with status quo
 - \$158 billion per year by end of decade
 - \$500 billion in first decade
 - all necessary care included (dental, hearing, vision, Rx, LTSS, etc.)
 - elevates remedies for inequity (racial, economic, rural, etc.)
- Outlines the decisions and actions that will move California toward a unified financing system for health care

Proposals to overhaul CA health care

State-based process

- Waiver Development Workgroup (SB770)
- program structure and governance (CalCare, AB1690)
- waiver agreement
- state funding bill
- constitutional issues

Concurrent federal action: Medicare for All Act (House [Jayapal]; Senate [Sanders])

Popular support

- community engagement
- voter education
- coalition
